# FOREWORD



I am very pleased to present the 23rd Annual report of 'SUPPORT' for the year 2020-21. Through the report we would like to share the key achievements and experiences with you all. The organization will be happy to receive feedback and valuable advice from you so that the organization can continue to succeed in achieving the set goals.

The year 2020-21 was very challenging for the organization due to inconvenience caused by the COVID-19 epidemic. It was challenging at that time to provide livelihood support and services to all the needy people in different communities. But we did not give up and were able to help the poor as much as possible. The organisation has provided some assistance to its target community in the form of 'Face Masks', 'Sanitizers', 'Soaps', 'Food Packets'. 'Masks' and 'sanitizers' were also made available for block offices, primary health centers and district administrations for distribution among the needy.

Under the close guidance of the district administration, coordination and facilitation was done to assist the safe entry of migrants and also support those affected by Covid 19.

The report of the 23rd Annual Report reflects the results and achievements of our commitment to the organizational vision. This year again the organization has launched Railway Child Line 1098 emergency service activities, collaboration with railway; quality education activities through online and offline classes; skill and capacity building of farmers and youth; farm and non-agricultural activities; livelihoods, community health and sanitation with women. These have been continued to strive towards excellence in addressing social and economic challenges through use of proper and appropriate technologies wherever possible. The organization is ensuring irrigation facilities in the project villages' by constructing water harvesting structures under climate-proofing and watershed management projects. The organization has provided skill training to the identified needy youth, strengthened the Farmers Producer Company (FPC), implemented TDF-Wadi projects in Hazaribagh and Bokaro districts, initiated 'Developed agriculture cluster' in Jaldega block of Simdega district and cultivated banana using the scientific method at Bandgaon block of West Singhbhum.

The organization has launched a BRLF-supported program based on the creation of a detailed project report (DPR) on how watershed functions and how ridge to valley treatment methods can be implemented by converting to MGNREGS. With the support of UNDP, the organization has implemented capacity building program for 1500 progressive farmers across 12 districts of Jharkhand for implementation of solar powered pumping systems. We continued to ensure securing social security schemes for the communities in the six blocks of Hazaribagh district with the support of Vikas Bazar Network. The Upbear Foundation has helped to initiate improved agriculture in eight districts of Jharkhand.

I feel that no work can be successful without the sincere efforts of our staff, volunteers and management team for which I am extremely grateful to them. I would like to thank all the donors and supporters like NABARD, UNDP, BRLF, CInI, Tata Trust, Jharkhand State Watershed Mission, Jharkhand Tribal Development Society, Bayer Foundation, AXIS Bank Foundation, EY, Barefoot, District Administration and other agencies. The organization is grateful to the well-wishers and individual supporters for their valuable support which we have received and is anticipated in the future. # 1. LIVELIHOOD PROMOTION : MISSION 2020

## LAKHPATI KISAN SMART GAON

Small and marginal farmers in rain-fed areas are largely dependent on traditional farming and suffer from a lack of assured irrigation, inadequate high quality seed and equipment and face the problems on accessing the proper consumer market. In response to this, SUPPORT in collaboration with CInI Tata Trusts is working on an ambitious and high impact program to bring about the rapid positive development and great sustainable change in the lives of the poor. To achieve this, a program - "Lakhpati Kisan" has been conceptualized and executed in the area for the last five years. The core focus of the program is meeting the aspirations of tribal and rural communities through specific livelihood prototypes, water conservation and irrigation systems through community institutions. The development, strengthening and handholding of farmer producer organizations and other such institutions are the major part of this program. The mission of Lakhpati Kisan for 2020 is to inevitably lift 4100 HHs out of poverty by increasing their annual income to at least Rs. 1,20,000 from a current annual average income of Rs. 60,000 within five years.

### KEY STRATEGIES



#### Community Mobilisation

Community institutions are now leading the action with robust Annual work plans, linking with different stakeholders, managing the community level resource persons to ensure quality delivery, providing various services to its members



#### Market Led Interventions

'Ensuring production at scale and linking the community with the markets. Various options of market linkages have been worked out with aggregation for dealing with traders and in places working with Farmer Producer Organisations.



#### Demand led Activities

Through the Community Institutions demands from within the community are collated and quality inputs (Seeds, fertilisers, etc) and services are provided to the households



#### Innovation- not Stereotype

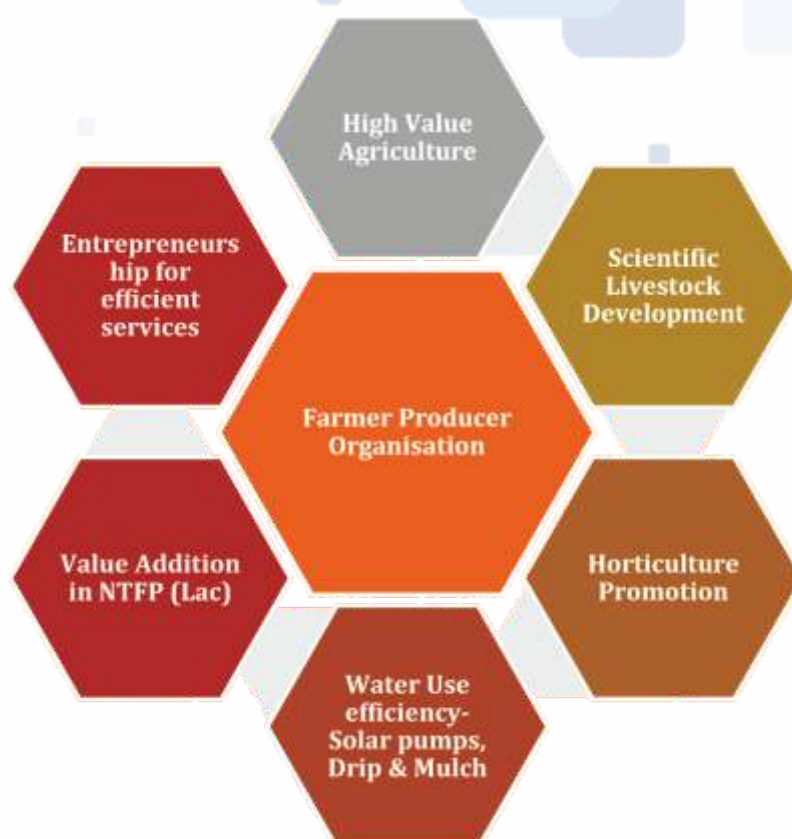
Innovative activities such as soilless nurseries, loan-based livelihood prototypes, solar irrigation linked with drip and mulch, brood lac treatment, farm mechanisation, ITE in education have been promoted and subsequently scaled up.

## Creation of Apex Community Based Institution

### High Value Agriculture

The core focus of the activities is to mobilize the households towards High Value commercial crops for increase in income from limited land holdings by optimizing technologies such as healthy soilless nursery-based saplings, Proper Package of Practices, drip irrigation with mulching, solar irrigation systems, farm mechanization, seed cultivation, etc. These technologies have widely been adopted by the farmers. Improved practices are adopted in vegetables which are planned for each season based on market demand. We have seen an increase in outreach in terms of number of farmers adopting High Value Agriculture and an increase in coverage of commercial crops. This has led to a net raise in household incomes of these farmers by at least 40%. The following table gives the progress for year 2020 in High Value Agriculture.

### **Scientific Livestock Rearing**

Improved and Scientific rearing of livestock is also a strategy for improving incomes of resource poor households and move them towards the path of Lakhpati Kisan. Under this, identified households are supported with good package of practices for livestock rearing which includes goats, pigs and aquaculture. In each of this segment , entrepreneurs are also trained as service providers to cater to good quality breed, health services and other services as needed by the households. Through improved livestock rearing , households have an opportunity to earn at least Rs. 15,000- Rs. 30,000 annually.

#### **Goat Rearing**

- Supported 3320 households for scientific goat rearing
- Improved Breed introduced
- 4 Goat Entrepreneurs promoted for better services

#### **Pig Rearing**

- Supported 550 households for quality pig rearing
- 13 entrepreneurs promoted

#### **Fisheries**

- Promoted 407 households for scientific fish rearing
- 6 fish entrepreneurs promoted

## Lac Cultivation

The abundance of natural trees in the region provides ample opportunities for lac cultivation as an income generating option for the communities in Churchu Block. SUPPORT under the Lakhpati Kisan initiative has supported lac cultivating families to adopt improved practices for better yield and has also helped set up village level lac processing unit so that some basic value addition can be done. In this year, with support of CInI, the organization has trained women to create various artefacts and bangles of lac with support of a professional designer. These products are gaining demand for their quality and finesse in the urban and rural markets. Kajri Lah Churi Kendra is supporting skills to young women and girls in preparing of bangles and artefacts which is sustaining their livelihoods.

10 Brood lac entrepreneurs have been supported to provide quality brood lac to farmers so that losses are minimized. Total outreach under Lac intervention is with 1121 households of which 723 farmers are in the July cycle and 698 farmers are in January cycle.

The Lac processing unit which is owned by Anjana VO at Kajri village supported brood treatment, linking quality brood requirement of farmers and capacity building of farmers in package of practices including efficient spray management. Overall, through these various pathways, we have seen improvement in household incomes from the baseline for the farmers in the area. The graph shows the various income ranges of farmers who are currently supported under the Lakhpati Kisan program.



## E-Shakti (Digitisation of SHG) in four districts of Jharkhand

E Shakti was launched with support of NABARD in the year 2016 and continues in 2020-21. It aims to digitize data of 11053 SHGs in 40 blocks for enhancing the ease of doing business with SHGs. This is also in line with the Government of India's "Digital India" mission. The uniqueness of E-Shakti project is "one- click' availability of social and financial information of the Self-help groups maintaining savings Bank accounts and an App loaded on Android based mobile which is handled by 368 animators who are responsible for 30 SHGs each.

The whole ecosystem is designed to capture all types of financial transactions like Member's savings, Internal Loan disbursement /payment, Bank Transactions in terms of savings/loans and non-financial operations viz. meeting decisions, etc at SHGs level and store the same in digital form on E-Shakti platform.

SMS alerts are sent to members on their savings and loan outstanding amounts. Every month a financial statement in Hindi/ English is provided to each digitized SHG. SUPPORT has a facility of MIS based reporting on groups and progress data is generated and progress tracked on a new real time basis through the NABARD eshakti.org portal.

- Customized Menu depending on User Access.
- Dynamic grading of SHGs
- SHG Savings reports

- Branch wise list of non-credit linked SHGs for easy monitoring by controlling offices.
- Standardization of reports based on the requirements of Banks and other agencies.
- Access the system generated loan applications.
- Post sanction of loans, performance of SHGs can be monitor through various MIS reports.

## Credit Intensification Drive through Village level Program – Hazaribagh

The Regional Office of NABARD set up a target to improve the progress of having credit facilities to the digitized SHGs. In order to achieve this some criteria have been developed to gear up the Credit Intensification Drive through conducting Village level Program which are listed below :

- Preparation of final list of SHGs to be credit linked along with proper KYC.
- Generation of loan application through E-SHAKTI Portal with the consent of SHGs,
- Follow up with concerned bank branches for credit linkage of SHGs,
- Updating of backlog credit linkage through Mobile App on Portal.
- Organizing Village Level Program for Credit Intensification Drive in accordance with bank branches and SHGs
- Updating of new Credit Linkage through Mobile App on Portal





# NATURAL RESOURCE MANAGEMENT

Under Natural Resource Management interventions, SUPPORT is implementing Watershed projects in Bokaro and Ramgarh districts. Diverse interventions to improve percolation of rainwater, increase surface water retention and reduce soil erosion have been undertaken in these locations which are also showing results of Climate proofing by increasing availability of water. These activities have helped farmers improve their agriculture production by being able to take a second crop on the treated lands. Even during the lockdown due to Covid 19, land-based activities were able to generate employment locally. SUPPORT also engaged in awareness creation on Covid appropriate behaviors, relief distribution to needy households and also supporting migrant households to reach their families. Alongwith Watershed interventions, SUPPORT has also carried forward the activities under Mahila Kisan Sashaktikaran Pariyojana which is in its completion phase. As part of this phase, consolidation of activities, assessment of impact and reaching out to last mile beneficiary households was undertaken in the year. The gains reaped by the farmers under MKSP shall be continued through improved organic cultivation practices and models of food and nutrition security,

- Project area : 725 Hectare
- Household :581
- Project Village: Barkachumba, Manjhalachumba, Chhotkachumba and Hesalong
- Chumba Nala Watershed Committee is registered under Societies Registration Act-1860
- 950 person days of work was generated during the lockdown through construction of Dobha, Field bunding, Azolla tank construction and Horticulture activity.
- 63 SHGs were involves in mask production and distribution
- 1220 masks and 200 soaps distributed in the area upto March 2021.
- Dry ration distribution through convergence program among 128 needy families
- Awareness and social distancing as well as handwash program were conducted in four villages
- Exposure visits were organised for 90 farmers
- Organic manure and organic vegetable cultivation was done with 455 farmers
- Quality seeds, fertilisers and eco-friendly manure was distributed to 150 farmers
- 260 acres of Upland has been treated and brought under agriculture use
- Natural Pesticides (NPM) was prepared and distributed among 245 farmers.

## **Mahila Kisan Sashaktikaran Yojana (MKSP)**

MKSP has been continued in the 20-21 as follow up of previous activities with no cost extension basis with the objectives of improving the status of 'Women farmers through Agriculture', and to enhance the opportunities for their empowerment. The core agenda of the project was to nurture sustainable institutions around agriculture and allied activities, develop sector and geography-specific best package of practices and create a wide pool of community resource persons for promotion of sustainable agriculture practices. More than 3000 small & marginal women farmers are members of more than 300 SHGs. These have been strengthened and promoted for adopting improved sustainable farming system resulting in achievement of year-round food and nutrition security.



### Program Impact

- Enhancement in household income of 85% of women farmers by Rs. 25,000 to Rs. 30,000 per woman farmer per annum
- Around 750 acres of additional land brought under cultivation.
- Cropping intensity area increased by 30% above baseline
- Productivity of major crops increased by 30%
- Production and use of quality compost increased by 50%
- Around 85% women farmers started using bio-fertilisers and microbial agents for cultivation
- Adoption of improved sustainable farming practices by more than 60% farmers
- At least 70% women farmers adopted drudgery reduction tools and techniques
- Around 25% higher price realization for agriculture produce cultivated through NPM method
- Establishment of community managed agriculture extension system comprising organization level trained personnel of 5 para professionals and 25 Community Resource Persons (CRPs)
- Strengthened 8 SHG Federations and 5 Producer Groups
- Around 30% increase in participation of women in Gram Sabhas and Panchayat Raj Institutions

### EDUCATION PROMOTION

Promoting quality education to the rural poor children in Ramgarh district is done through a Support Public School managed by SUPPORT through a proper school setup with trained teachers who are engaged in providing joyful education to children from economically weaker households. The school is managed by SUPPORT with a separate Management unit responsible for the governance of the school. It follows the CBSE curriculum and has a student strength of 250 and 20 staff including teaching and non teaching staff. The school compound is well equipped with Children's Park, Playground, Library, Auditorium, Transport facility, Washrooms and Drinking Water facility. As the school was closed due to nationwide lockdown because of Covid 19 pandemic, we shifted to online mode of instructions for the children. Teachers were trained on using online mode to teach the students. Parents were contacted and guided on the process of online class rules.

SUPPORT is looking forward to an asset improvement agreement to work together on a Smart Education Project' to improve education infrastructure and learning ability of students attending the school. Individual donors are also supporting to meet the financial requirements of school.

### CHILD PROTECTION

Child line 1098 emergency service program has been launched on 1st September 2020 in the capacity of Railway collab -Barkakhana junction .Full-fledged branch office were established at Pochra village near Barkakhana railway station.12 Team members have been deployed after following the appointment process. Child help desk has been established at platform number 03 in Barkakhana railway junction. During Covid 19 lockdown, staff continued to work and provide assistance for locating and rehabilitating missing children. Apart from rescue and rehabilitation of children belonging to the age group below 18 years , the organization has organised Poshan maah (Nutrition Month) program ,Swachhta abhiyan program (Cleanliness Program),Child line se dosti (Friends with Child Line) program, enrollment drive in the catchment area of

Railway collab -Barkakana. Coordination meetings were held with Station Superintendent ,Railways Police force, and ,GRPF team . Meetings were also held with ADRM also to update him of the activities and seek his suggestions and cooperation.

Child line 1098 has been established for the fulfilling the following issues:

Life Survival of Children

Protection from different types of violence

Physical, mental and psycho social development

Participation in decision making processes.

The team of SUPPORT has tried to protect children from physical, social, sexual and economical abuse through Child friendly approaches. A total of 12 cases of missing children were tackled and traced. These children were rehabilitated as per their context- either with their families or with Shelter homes of the Government . The following cases were identified with the children

- Shelter case,
- Restoration case
- Medical case
- Sponsorship case
- Missing case.
- And emotional support case.

Overall with support of Childline India Fund (CIF) the team was able to continue the activities which were supported by Childline through various training sessions like Child Protection Laws, Financial and Reporting systems and Outreach Program. The team conducted 3 outreach programs each month and important days were celebrated with the children.



# COMMUNITY HEALTH PROGRAM

**U**nder Community Health Program , SUPPORT works with rural people to make them aware on the importance of hygiene and sanitation and safe drinking water. Through a range of motivation drives, awareness and behavioural change programs , the teams engage with the communities to create Open Defecation Free villages by supporting households to construct individual household toilets under Swachh Bharat Abhiyan. Alongside, behavioural practices like handwashing with soap, safe handling of drinking water, Menstrual health and Hygiene are also areas where we engage with the people and create awareness on Behaviour Change . In this year, the team also scaled up initiatives on Menstrual Hygiene Management by reaching out to women and girls in nearly 40 villages. The section below highlights the key activities and achievements in the year.

## Activities during the year

- With the outbreak of Covid- 19 pandemics, mass awareness program across rural community was done through audio and video dissemination safety and care during Covid.
- Base line survey across 3500 households for toilet accessibility & its usability
- Toilet access for Lakhpati Kisan and community persons through Retrofitting activities
- Successful IoT pilot sensor based first installation in Jharkhand at Kajri Water Tank, Churchu, Hazaribagh
- SHG meeting and door-to-door visit towards ODF sustainability.
- Demand generation done for Tata Swachh water filters.
- Day celebration-Water Day, ODF celebration and Swachhta Diwas

## Key Achievements during the year

1. Base line survey Analysis shows Toilet accessibility remains 87% while usability stands at 61% in operational areas of Churchu Block
2. Retrofitting of 45 toilets completed with own contribution of the households.
3. A total of 123 new household toilets constructed during the year. OF these 101 households received subsidy under Swachh Bharat Mission while 22 households constructed toilets from their own resources.
4. 190 households undertook repair of their toilets which also included 57 Lakhpati Kisan households,
5. 553 household toilets were brought under use through motivation and awareness. This included toilets of 179 Lakhpati Kisan households.
6. Demand creation for Point of Use Purification system for drinking water was done and 212 households purchased Household water purifiers

## Under Menstrual Hygiene Management the following activities were undertaken

- MHM training sessions were conducted among women and adolescents in the operating villages.
- Organized cloth pad stitching workshops
- Organized couple counselling sessions
- Important days like -Menstrual Hygiene Day on 28th May 2020, Periods Day celebration on 5th February 2021 and International Women's Day celebration on 8th March 2021 was done with community members.
- Safe disposal of menstrual waste was demonstrated through Matka Incinerator installation at household level
- Board of Directors of Churchu FPC and Team members of the project oriented on the importance of Menstrual Hygiene.
- Impact assessment of Menstrual Hygiene Management sessions was done with 70 women and adolescent girls.



### Key Achievements under MHM

- MHM training outreach among the women and adolescents is 1556.
- Couple counselling training sessions on the importance of Menstrual Health have been conducted with 57 couples
- Total of 53 cloth pad stitching workshops have been conducted with 805 participants
- Total 49 Matka incinerators have been installed in 129 households.

#### Case Story: Self Motivated Toilet and Bathing Room Constructed by Rose Mary

Rose Mary Tirkey, 34 years lives in a small village called Dumar in Churchu Block of Hazaribagh district, with her husband Rajesh Murmu and two sons-16 and 9 years, respectively. She and her family used to practice open defecation since they did not have a toilet at their home. She expressed her discomfort for open defecation to the staff when they discussed with her about the ill effects of the same. However, lack of money was a challenge and she did not have proper understanding of the costs as well as design of the toilet.

SUPPORT team members explained the design of the toilet and also motivated her to construct a bathing space adjacent to the toilet so that the family could also bathe properly in private. The team encouraged her to collect materials locally and the family contributed labour for construction of toilet. Rose Mary had tried to contact the Mukhiya of the Gram Panchayat as well as the Jal Sahiya who are responsible for enlisting households for toilet construction with support of incentive from Government, but she was not able to get her name in the list. However, she was determined to have a toilet in her house and with encouragement of the team, she and her family constructed a toilet and a bathing space. She is delighted that she could achieve what she had initially felt impossible to do with her own resources. SUPPORT is also helping her to get the documents ready to apply for the incentive under Swach Bharat Mission, so that she will be able to get some financial relief. Today Rose Mary is proud and also is a motivator for other households in her village to stop open defecation and have a hygienic facility in their houses.



## TRIBAL DEVELOPMENT PROGRAM : JTELP DUMKA

Jharkhand Tribal Empowerment and Livelihood Program (JTELP) has been building on the experience and successful completion of IFAD supported Jharkhand Tribal Development Scheme (JTDS) . Under this program the interventions are under three main components a) Community Empowerment b) Integrated Natural Resource Management c) Livelihoods Support.

Total 58 GSPEC at village level has been strengthened and these organisations have been provided Village Development Fund by JTDS, Dumka. A total of 210 SHGs have been handed over to JSLPS Dumka district. Total 22 Youth Groups (YG) formed and they have been linked to Nehru Yuva Kendra, Dumka.

## ITDA CHAIBASA AND SIMDEGA



With support of ITDA West Singhbhum, scientific cultivation of banana plantation started at Otar Panchayat of Bandgaon Block of two villages namely Bastampada and Jomro-Putusiai. A total of 18 farmers have been supported with scientific methods of banana cultivation in 19 acres of land. These farmers have been provided technical support including fencing, gap filling, manuring, drip irrigation and good quality saplings. A total of 3 project level staff are involved under close supervision of Project Coordinator to undertake these activities.



With support of ITDA Simdega, Vegetable cluster development project was started at Lamdega Panchayat of Jaldega Block in Simdega district. A total of 50 acres of land is being covered under this project involving a total of 50 farmers who are tribal, for promotion of vegetable cluster. These farmers have been supported with deep boring, fencing, land levelling, improved seeds, horticulture saplings and manure as well as pesticides. Farmers were trained by experts on better and improved vegetable cultivation.

## TDF WADI Churchu Hazaribag, and Bokaro Project

Based on the successful experience of Adivasi Development Programmes, NABARD embarked upon an ambitious program of replicating the wadi model across the country. In this direction, NABARD created a Tribal Development Fund (TDF) in 2003-04. To promote sustainable participatory livelihood program which inter alia, aim at economic uplift through sustainable agriculture, social empowerment, improvement in quality of life including health and women development, in tribal predominant areas of the country through demonstration projects. The objective of the Fund is to create replicable models of integrated development of tribal families on a participatory basis, through the adoption of sustainable income-generating activities and to build, strengthen tribal institutions which enable mainstreaming the communities by improving their socio-economic status. Over the years supporting the tribal communities with wadi, as the core component has been the focus area of the TDF program.

SUPPORT is implementing TDF WADI projects in Churchu block of Hazaribag district and expanding in Jaridih block of Bokaro district with its funding support by NABARD. The program intends to take up horticulture development activities in 1569 Acres, Soil & Moisture conservation activities in 1045 acres, and water resource development in 1963 acres. Summary of activities taken up in the current financial year and cumulative statistics are provided overleaf:

## CAPACITY BUILDING

**P**M-KUSUM scheme was initiated by Government of India to increase the income of farmers and provide source of irrigation. Under this initiative, the state implementing agency JREDA with the support of UNDP and SUPPORT tried to reach the remotest and the neediest of the farmers who can use solar power irrigation system in an optimal manner. 1527 farmers were sensitized, trained and their capacity built on sustainable use of these pumps as well as sustainable agricultural practices. The intervention by SUPPORT and UNDP was to meet the twin objectives of Government of India's aim of doubling farmers' income and taking forward India's commitment to the flagship program of Government of India.

Awareness creation and sensitization of farmers, motivational training and capacity building was done to ensure that farmers in the remotest locations are aware of the benefits under PM KUSUM yojana. The farmers were made aware of the national and international commitments towards Climate Change and use of renewable energy and the role that the farmer plays in taking forward such commitments. Government of Jharkhand has a target of ensuring 8000 solar powered pumps to farmers in the year 2019-20 which was the first phase of the project. SUPPORT has supported the farmers with the necessary documentation to avail benefits under the scheme. The applications are under consideration by the Government and are yet to be actualized. However, SUPPORT feels that the large-scale awareness did help create the necessary demand for renewable energy supported solar powered pumps in the region.

### Objectives

The intervention tried to cater towards multiple aspects from agriculture to sustainability for the targeted objectives:

- 1500 Farmers e sensitized about the PM-KUSUM schemes so that the farmers can take benefits of the scheme.
- The farmers who are not able to apply within the existing project apply for the forthcoming financial year targets within the scheme.
- Farmers get round the year availability of water for irrigation. Farmers are made aware and undertake sustainable agriculture practices
- Train farmers on judicious use of underground water
- Train and sensitize farmers on environmental sustainability

The districts of Ramgarh, Hazaribagh, Chatra, Giridih, Deoghar, Dumka, Godda, Dhanbad, Bokaro and Jamtara are covered under Capacity building on adoption of renewable energy.

Under Credit Linkage a total of 30 applicants were supported and their applications were registered online for availing credit for self-business or self-enterprises in Hazaribagh district.

## INSTITUTION BUILDING

**F**ormation and promotion of community-based institutions like SHGs, VO's, PGs, Federation, Youth clubs, User groups are the primary strategies adopted for increasing collectivization and better access to markets for the produce grown by farmers in the area. Most Institutions have membership of Male and Female farmers. The table below shows the various Farmers' Collectives promoted by SUPPORT in different districts. These Institutions were provided with technical support, financial linkages and Marketing support by the Organization. Farmer Producers' Groups have worked with E-NAM Portal for marketing which was also supported by the District level Department. During the nationwide lock down period FPO -Churchu Nari Urja Farmer Producer Company Limited continued to provide input as well as marketing support to its member farmers for summer vegetables and water melon
